OFFICIAL CONTEST RULES

The Westgate SuperBook Big Game Prop Contest (hereinafter the "Contest") refers to the events occurring between Saturday, January 1, 2022 and Sunday, February 13, 2022 (unless any make-up game become necessary per rule 7) ("Contest Period") at the Westgate Las Vegas Resort & Casino ("Sponsor") located at 3000 Paradise Road, Las Vegas, Nevada 89109. All references to time of day contained herein refer to Las Vegas, Nevada Time.

1. All contestants must be at least 21 years of age to participate. Contestants must provide valid proof of age that is acceptable to the Westgate Las Vegas Resort & Casino (current driver's license, passport, or state identification card), which may act in its sole and absolute discretion as it deems appropriate. If contestant is not a U.S. resident, a current passport or alien registration card is required.
2. Contestants will be required to swipe their Westgate Las Vegas Resort & Casino WOW Rewards card at the Westgate Las Vegas SuperBook self-service contest window to make their selections. By signing the official entry form, the entrant becomes the "official contestant" and is the only one approved to collect prize money.
3. Westgate Las Vegas Resort & Casino WOW Rewards card are free and are available at the WOW Rewards Center, Casino cage or the SuperBook.
4. Contestants can participate in the Westgate Las Vegas SuperBook Big Game Prop Contest by paying a fee of one hundred dollars (\$100) per entry. Entry fees are valid all season and are non-refundable. Entry fees can only be paid in cash.
5. Entry fees will be accepted for the Westgate Las Vegas SuperBook Big Game Prop Contest from 9:00 a.m. on Saturday, January 1, 2022 through 2:00 p.m. on Sunday, February 13, 2022. If the game is delayed entry fees will be accepted until 90 minutes before scheduled kickoff.
6. Maximum of three (3) entries per contestant. Each entry shall be treated as a separate entry for all purposes.
7. The Westgate Las Vegas SuperBook Big Game Prop Contest will begin Saturday, January 1, 2022 at 9:00 a.m. and conclude on Sunday, February 13, 2022 with the conclusion of the SB LVI game. In the event the game is delayed the contest would conclude on the date the game becomes official but no later than February 28, 2022.
8. Players must play in SB LVI for action. Any prop where a player doesn't play will be eliminated from the contest.
9. The Westgate Las Vegas SuperBook Big Game Prop Contest is based on selecting thirty (30) winning props results for SB LVI. Contest prop lines will be set by the Westgate Las Vegas SuperBook. Contest lines will not move once they are set. Contestants must select one side for each of the thirty (30) props. In the event a contestant has multiple entries they may select one side on one entry and the opposite side on another entry.
10. Contest winner will be determined by the total number of points accumulated during SB LVI. Each winning selection will earn one (1) point. In the event a contestant has multiple entries points do not combine.
11. Contestants must submit their selections at the Westgate Las Vegas SuperBook or via the Westgate SuperBook Mobile App between Saturday, February 5, 2022 at 9:00 a.m. and 2:00 p.m. on Sunday, February 13, 2022. In the event the game is delayed, selections can be extended up to 90 minutes before scheduled kickoff. Contestants who have a Westgate SuperBook mobile wagering account can submit selections by the deadline as long as they are located in the approved geographic boundary. The Westgate SuperBook is not responsible for any technical difficulties, malfunctions or any predictable or unforeseen issues regardless of whether the issues are on the end of the SuperBook app or the contestant. Each contestant is therefore responsible for submitting his/her picks over the counter before the 2:00 p.m. deadline on Sunday, February 13, 2022 in the event they are unable to do so via the mobile app. This deadline will be strictly enforced. Contestants who fail to submit their selections will be awarded zero (0) points for each prop.
12. The selection ticket (receipt) generated by the Westgate Las Vegas SuperBook computer system is the official entry of record. The contestant's official selections will be those contained in the Westgate Las Vegas SuperBook computer system records. If a selection ticket is not produced via the self-service contest window the contestant must notify a Westgate Las Vegas SuperBook supervisor immediately to receive a printed copy of their selections. The "selection sheet" itself is not an official entry of record.

13. Selections are only submitted once per contest entry. Contestants cannot void selections after the Westgate SuperBook business day they are submitted. All Westgate Las Vegas SuperBook Big Game Prop Contest selection ticket void requests must be submitted to a Westgate Las Vegas SuperBook supervisor for approval. In the event a contestant has multiple entries, a contestant must submit separate selections for each entry. If more than one (1) selection is erroneously accepted for an entry, the first selection associated with that entry will be the official selection of record.
14. All contest entry fees will be paid to contest winners under the following winner's schedule:
 - 50% will go to first (1st) place
 - 30% will go to second (2nd) place
 - 20% will go to third (3rd) place
15. All contestants will enter the combined total score for SB LVI as the tiebreaker. In the event of any ties for all places (1st – 3rd), the contestant who is closest to the winning point total will be declared the winner. Should any ties still exist after this tiebreaker; aggregate prize money will be split equally.
- 16. All Westgate Las Vegas SuperBook house rules apply to this contest unless otherwise stipulated in these rules.**
17. The Westgate Las Vegas SuperBook reserves the right to cancel this contest or refuse to accept any registration or wager if the same could violate any federal, state or county law, ordinance or regulation. Furthermore, the Westgate Las Vegas SuperBook may cancel the contest in the event of technical difficulties or other occurrences beyond the control of the Westgate Las Vegas SuperBook.
18. Selections may be accepted manually in case of a computer system failure or other unforeseen circumstances as deemed necessary by the Westgate Las Vegas SuperBook management.
19. Entry fees will not be refunded for reasons other than the cancellation of the Westgate Las Vegas SuperBook Big Game Prop Contest.
20. NFL.COM and ESPN.COM will be the official sources used for all result, for tackle props, only NFL.com box score will be used.
21. After the final results are posted on Monday, February 14, 2022, (unless the game is in delay) a one (1) day verification period will occur. Any disputes with the contest and / or results must be provided to management in writing within this verification period. At the end of the one (1) day verification period, the Westgate Las Vegas SuperBook Big Game Prop results will be declared official. In the event of a dispute, the decision of management is final.
22. Employees as well as family and household members of the Westgate Las Vegas Resort & Casino may not participate in the Westgate Las Vegas SuperBook Big Game Prop Contest.
23. All contestants agree to grant the Westgate Las Vegas Resort & Casino unconditional use of their name and likeness for promotion as / advertising and announcements without compensation, consideration, notice review or consent.
24. All decisions regarding the interpretation of rules, eligibility, etc. for this promotion lie solely with the Westgate Las Vegas Resort & Casino whose decisions are final.
25. All references to time of day contained in these rules refer to Las Vegas, Nevada time.
26. All entries are subject to review and verification.
27. Westgate Las Vegas Resort & Casino reserves the right to modify or cancel this contest at any time for any reason, subject to any applicable regulatory approval provided that such modification shall not, as the date of such modification, materially alter or change any participant's prize already awarded.
28. Westgate Las Vegas Resort & Casino may disqualify any person for any prize based upon the Westgate Las Vegas Resort & Casino's belief of the possible commission of fraud, dishonest violation of contest rules or other misconduct whether or not related to this contest.
29. A record of entries will be retained for record keeping purposes in accordance with legal requirements.
30. Individuals who are excluded from casino facilities, including through a government program, at the Westgate Las Vegas Resort & Casino discretion, or by their own request, are not eligible to participate or win any prize.
