

# **MOBILE SPORTS BET RULES**

## Westgate Mobile Sports Bet – Official Rules

1. By opening a Westgate Las Vegas SuperBook Mobile Sports Bet wagering account, you agree to comply with and be legally bound by these rules, as well as Westgate Las Vegas SuperBook Mobile Sports Bet's terms of use, privacy policy, and any house rules or specific event wagering rules that may apply to your Westgate Las Vegas SuperBook Mobile Sports Bet wagering account or wagering activities using the account. If you do not accept and agree to the terms of use, rules, and privacy policy of Westgate Las Vegas SuperBook Mobile Sports Bet, you may not use Westgate Las Vegas SuperBook Mobile Sports Bet in any way.

2. Westgate Las Vegas SuperBook Mobile Sports Bet wagers are only accepted within the State of Nevada. Nevada law prohibits wagers originating from outside the State of Nevada. It is illegal to place a wager originating outside the State of Nevada using Westgate Las Vegas SuperBook Mobile Sports Bet.

3. All Westgate Las Vegas SuperBook Mobile Sports Bet applications must be made in person and applicants must provide Westgate Las Vegas Resort & Casino with an acceptable and valid proof of government-issued identification, proof of residence, social security number, and other information.

4. All account applicants must be twenty-one (21) years or older.

5. All account applicants and holders must be a member of the Westgate Las Vegas WOW Rewards. Your Westgate Las Vegas WOW Rewards number is also your Westgate Las Vegas SuperBook Mobile Sports Bet wagering account number.

6. All Westgate Las Vegas SuperBook Mobile Sports Bet wagering accounts transactions, including deposits and withdrawals, must be made by the account holders only. Agents or other representatives are not permitted. Wagering accounts may be used only by the person named on the application of such account. The initial deposit into a wagering account must be made in person and signed and authorized by the account holder at Westgate Las Vegas SuperBook during normal business hours. Subsequent deposits or withdrawals can be made in person at the Westgate Las Vegas SuperBook or through an approved third-party partner by the account holder.

7. A minimum deposit of one hundred dollars (\$100) is required to open a wagering account. Deposits to wagering accounts must be made with cash, approved chips and/or tokens.

8. Westgate Las Vegas SuperBook Mobile Sports Bet patrons are required to provide account number and an acceptable valid photo identification when conducting account transactions.

9. A Westgate Las Vegas SuperBook Mobile Sports Bet wager will not be accepted if the total value of the wager exceeds the wagering account's balance.

10. Westgate Las Vegas SuperBook Mobile Sports Bet wagers are subject to established wagering limits that may vary from sport to sport or type of wager within any particular sport. The minimum wager is two dollars (\$2) using your wagering account.

11. Westgate Las Vegas SuperBook Mobile Sports Bet wagers are accepted 24 hours a day, unless Westgate Las Vegas determines otherwise.

12. Westgate Las Vegas SuperBook House Rules, upon regulatory review, are subject to change by Westgate Las Vegas at any time. Please visit our website at:

13. Westgate Las Vegas may update or change the Westgate Las Vegas SuperBook Mobile Sports Bet rules, terms of use, or privacy policy periodically at our sole discretion and without advance notice to you. Your continued use of your Westgate Las Vegas SuperBook Mobile Sports Bet wagering account after the posting of any change to the rules, terms of use, or privacy policy constitutes your binding acceptance of such change. If any change is unacceptable to you, you must immediately cease using Westgate Las Vegas SuperBook Mobile Sports Bet entirely and close your Westgate Las Vegas SuperBook Mobile Sports Bet wagering account.

14. All applicable Westgate Las Vegas SuperBook house rules and regulations apply to Westgate Las Vegas SuperBook Mobile Sports Bet wagering accounts. Specific event rules and stipulations also apply to all Westgate Las Vegas SuperBook Mobile Sports Bet wagers.

15. Upon reasonable request, Westgate Las Vegas will provide patrons a statement of account showing each wagering account deposit, each wagering account withdrawal, each credit to your wagering account, and each debit to the wagering account made during the time period reported by the account statement. Patrons may dispute any transaction pursuant to Nevada Gaming Commission Regulation 7A or Title 41 of the 2010 Nevada Code (NRS 463.361-463.366), as applicable.

16. Westgate Las Vegas will create a print, electronic, or other approved record of the entirety of each Westgate Las Vegas SuperBook Mobile Sports Bet transaction and shall not accept any wager or transaction if the recording system is inoperable. Recorded wagering transactions shall be maintained for a minimum of one hundred and twenty (120) days. The record of the patron's confirmation of all wagering information shall be deemed to be the transaction of record, regardless of what was recorded by the computerized bookmaking system. The transaction records are made available to the Nevada Gaming Commission and Control Board upon request.

17. You acknowledge that a wager placed using Westgate Las Vegas SuperBook Mobile Sports Bet is binding on you and Westgate Las Vegas only when the Westgate Las Vegas Mobile Sports Bet system is operating and displays.



You press Yes and the system displays:

18. Once a wager has been accepted by the Westgate Las Vegas SuperBook Mobile Sports Bet system and displays the above confirmation message, the wager is binding to both parties and CANNOT be cancelled by either party.

19. Westgate Las Vegas, in its sole discretion, has the right to:

a) Refuse the establishment or maintenance of any and all Westgate Las Vegas SuperBook Mobile Sports Bet wagering accounts.

- b) Refuse deposits to accounts.
- c) Refuse to accept all or part of any wager.

d) Declare the account wagering system closed from receiving any of all wagers.

e) Suspend or close any account at any time provided, however, that when an account is closed, Westgate Las Vegas shall, within five (5) business days, return the balance of the wagering account from the time of said action, subject to compliance with Nevada Gaming Commission and Control Board regulations. Westgate Las Vegas house rules, and federal and state laws and regulations, by sending a check to the patron's address of record.

f) Close any wagering account when an account holder attempts to operate with an insufficient balance or when the account is dormant for an unacceptably long period of time, as determined by Westgate Las Vegas in its sole discretion. In either case, Westgate Las Vegas shall refund the

balance of the Westgate Las Vegas SuperBook Mobile Sports Bet wagering account subject to compliance with Nevada Gaming Commission and Control Board regulations. Westgate Las Vegs house rules, and federal or state law.

20. Westgate Las Vegas takes reasonable steps to keep your information confidential, except when Westgate Las Vegas is required to share such information with the Nevada Gaming Commission or Control Board or as otherwise required by applicable state, federal, or other law. By opening a Westgate Las Vegas SuperBook Mobile Sports Bet wagering account, you agree that Westgate Las Vegas may share your personal information with others outside Westgate Las Vegas, with regard to wagering information. Westgate Las Vegas shall keep confidential, except from you, the Nevada Gaming Commission or Control Board, or as otherwise required by federal or state law: (a) the amount of money credited to, debited from, or present in any particular patron's wagering account, (b) the amount of money wagered by a particular patron on any event, (c) the account number and secure personal identification method that identifies the patron, and (d) the identities of particular entries on which a patron is wagering or has wagered. ### **COLLEGE FOOTBALL REGULAR SEASON WINS**

\*TEAMS MUST PLAY 12 REGULAR SEASON GAMES FOR ACTION UNLESS THAT TEAM HAS A DEVIATION, THEY MUST PLAY ALL OF THEIR SCHEDULED REGULAR SEASON GAMES \*WAGERS DO NOT INCLUDE POST SEASON GAMES (CHAMPIONSHIP GAMES AND/OR BOWL GAMES) \*TEAMS MUST PLAY ALL SCHEDULED OPPONENTS WAGERS WILL BE PAID FOLLOWING THE CONCLUSION OF THE TEAM'S LAST REGULAR SEASON GAME

### PRO BASEBALL REGULAR SEASON WINS

\*TEAMS MUST PLAY AT LEAST 155 REGULAR SEASON GAMES FOR ACTION \*WAGERS DO NOT INCLUDE POST SEASON GAMES WAGERS WILL BE PAID FOLLOWING THE CONCLUSION OF THE TEAM'S LAST REGULAR SEASON GAME

#### PRO BASKETBALL REGULAR SEASON WINS

\*TEAMS MUST PLAY 79 REGULAR SEASON GAMES FOR ACTION \*WAGERS DO NOT INCLUDE POST SEASON GAMES WAGERS WILL BE PAID FOLLOWING THE CONCLUSION OF THE TEAM'S LAST REGULAR SEASON GAME

### PRO HOCKEY REGULAR SEASON POINTS

\*TEAMS MUST PLAY 79 REGULAR SEASON GAMES FOR ACTION \*WAGERS DO NOT INCLUDE POST SEASON GAMES WAGERS WILL BE PAID FOLLOWING THE CONCLUSION OF THE TEAM'S LAST REGULAR SEASON GAME

#### SOCCER

2-WAY (HANDICAP), TOTALS, AND 3-WAY (INCLUDING DRAW) SOCCER WAGERS ARE FOR 90 MINUTES PLUS INJURY TIME. EXTRA TIME (OVERTIME) AND PENALTY KICKS ARE NOT INCLUDED IN THESE WAGERS

"TO ADVANCE OR TO WIN OUTRIGHT," SOCCER WAGERS INCLUDE EXTRA TIME (OVERTIME) AND PENALTY KICKS. THE WINNERS OF THE MATCH AT ITS NATURAL CONCLUSION WINS THE WAGER REGARDLESS OF THE LENGTH OF PLAY BEYOND 90 MINUTES
